## Substitution/Corrigendum/Addendum as Modalities of ESE

In view of the Revised Guidelines published on 06-07-2020 by UGC, the following substitution/addendum is issued in respect 'A. Theory paper' in the modalities of ESE for the State Polytechnics circulated vide No. SCTE-4/2020/223 dated Guwahati, the 2<sup>nd</sup> June, 2020.

## A. Theory Paper [Only for final semester, 6th Semester]:

- The total marks (100%) of all the subjects will be on the basis of the Examinations to be held in August/ September, 2020, i.e., during the current session only. This Examination will be of two hours duration. The type of question paper will be conceptual and understanding based. The distribution of the number of questions will be as follows:
- The 80% of total marks will be from home based written examination to be monitored by online app like Google Meet, Microsoft Team, etc. For subjects having total marks 70: Written Examination = 56 marks: ten objective questions of 1 mark each, four/five/six questions of 3 marks, three/ four questions of 4 marks and two/ three questions of 5 marks.

For subjects having total marks 100: Written Examination = 80 marks: ten objective questions of 1 mark each, four/ five/ six questions of 3 marks, three/ four/ five questions of 4 marks and two/ three/ four questions of 5 marks and two/ three questions of 10 marks.

The remaining 20% of total marks will be from Viva-Voce, which will be conducted by
a Group of Faculties [GOF] through meeting app/telephone etc. The viva-Voce
examination will be structured and based on predefined set of questions that will be
provided by the SCTE, Assam, subject wise.
